**Ad 1.** The minutes of the previous meeting of the Management Board held on 9<sup>th</sup> March 2010 were shortly discussed and commented. The adoption of the minutes of the extraordinary General Meeting of the Society held on 26<sup>th</sup> March 2010 during the Symposium of Arrhythmias was confirmed.

Prof. Bergovec suggested that in the future a person should be elected and put in charge for every initiative of the Management Board that will contact the members as to



određeni zadatak. Komentar je bio poglavito vezan za problem propisivanja klopidogetra te odluke UO da se Radna skupina (RS) za akutni koronarni sindrom i kliničku farmakologiju angažiraju na stručnom elaboratu o primjeni klopidogetra. Stoga je dogovoreno da prof. Miličić kontaktira prof. dr. sc. Nikolić-Heitzlera, a dr. Počanić doc. dr. sc. Kneževića u svezi dopisa. Doc. Strozzi je također obećala da će kontaktirati prof. dr. sc. Ernsta kao predsjednika RS za invazivnu kardiologiju. Opći je zaključak da, na žalost, naši članovi premalo čitaju objave društva na webu.

**Ad 2.** Prof. Miličić je članove UO izvjestio o sadržaju dopisa dr. Strizrepa iz Hrvatskog zavoda za zdravstveno osiguranje koji predstavlja odgovor na dopis HKD-a kojim se argumentiralo da se iz bolničkog proračuna posebno izdvoje skupi uređaji, poput ICD i CRT-D, kao što su onkološki lijekovi izdvojeni iz bolničkih proračuna.

Dopis dr. Strizrepa je negativan te polazi od činjenice da su svi terapijski postupci u bolničkim proračunima, koji se ne dodjeljuju posebno klinikama i zavodima nego cijeloj instituciji.

**Ad 3.** Svi nazočni članovi UO sudjelovali su i u radu 11. simpozija o aritmijama, RS za aritmije i elektrostimulaciju te su simpozij ocijenili uspješnim.

Ponovno je naglašeno kako bi se sva događanja pod pokroviteljstvom HKD trebala unaprijed najaviti UO, kako bi se uskladili termini s mnogobrojnim drugim inozemnim i tuzemnim aktivnostima članova.

**Ad 4.** Prof. Miličić i prof. Bergovec su izvjestili o vrlo velikom uspjehu studentskog kongresa koji je održan na našem fakultetu. Posjećenost je bila velika, sudjelovali su i studenti iz inozemstva, a ova aktivnost vrednovana je kao izborni predmet studentima. Stoga je sudjelovanje u radu bilo i strogo kontrolirano.

**Ad 5.** Prof. Miličić je članove UO podsjetio na predstojeće aktivnosti:

Jukić) te o ulozi aliskirena kao reninskog antagonista u liječenju hipertenzije (Prof. Jelaković).

perform a certain task. The comment was mainly connected with the problem regarding prescribing clopidogrel and the decision by the MB that the Working Group (WG) for acute coronary syndrome and clinical pharmacology should be engaged in professional study of application of clopidogrel. Therefore it was agreed that Prof. Miličić should contact Prof. Nikolić-Heitzler, PhD and Dr. Počanić should contact Ass. Prof. Knežević, PhD in connection with the letter. Ass. Prof. Strozzi also promised to contact Prof. Ernst, PhD as the WG President for invasive cardiology. The general conclusion is, unfortunately, that our members read notices on web too little.

**Ad 2.** Prof. Miličić informed the MB members of contents of the letter by Dr. Strizrep from the HZZO that provides an answer to the letter by CCS that provided reasons for separating specially expensive devices such as ICD and CRT-D from the hospital budgets the same way that oncology drugs are separated from the hospital budget.

The letter by Dr. Strizrep is negative and the starting point is that all therapeutic procedures are included in the hospital budgets that are not assigned to clinics and institutes individually, but to the whole institution.

**Ad 3.** All present members of the MB participated in the work of the 11<sup>th</sup> Symposium of Arrhythmias, WG for Arrhythmias and Electrostimulation and evaluated the Symposium as successful.

It was again emphasized that all events under auspices of the CCS should be announced by the MB in advance as to coordinate the terms with many foreign and local members' activities.

**Ad 4.** Prof. Miličić and Prof. Bergovec informed them about a great success of the student's congress held at our Faculty. The number of visitors was great, foreign students participated in the congress as well, and this activity was evaluated as the elective subject for the students. Therefore, the participation in the work was strictly controlled.

**Ad 5.** Prof. Miličić reminded the MB members of the following activities:

29. svibnja: prof. Miličić pozvani gost predavač na kardiološkom kongresu Udruženja kardiologa Bosne i Hercegovine.

21.-24. listopada: 8. kongres Hrvatskog kardiološkog društva u Opatiji. Ponovno je prof. Miličić upozorio da je rok za prijem radova 1. srpnja 2010. godine.

Ad 6. Tajnik društva (dr. Počanić) upoznao je nazočne s aktivnostima na daljem sređivanju popisa članova HKD-a i postupka naplate članarina. Rizničar društva, dr. Margetić je prezentirao popis iz nekih institucija koje su nas obavijestile o ustezanju članarine s plaće. Prema popisu, KB Dubrava — 13 članova; Thalassotherapia Opatija — 22 člana, Poliklinika "Srčana" — 20 članova, KB Merkur — 8 članova, KB Sestre Milosrdnice — 18 članova, Poliklinika Sunce - 6 članova, ŽB Čakovec — 2 člana, OB Varaždin — 1 član, OB Pula — 6 članova, OB Slavonski Brod — 4 člana. Radi se samo o ustanovama koje su poslale obavijest, neke sigurno nisu, ali nam je za evidenciju nužno dobiti povratnu informaciju iz računovodstva institucija. Naglašeno je da se moraju angažirati naši istaknuti članovi u zdravstvenim ustanovama diljem zemlje da podsjetite kolege na obavezu plaćanja članarine i sređivanje popisa članstva.

Tajnik je potom prikazao novozaprimljene molbe za članstvo u HKD: dr. Iva Henezi, Srčana Zagreb, dr. Arben Ameti, Srčana, Zagreb, dr. Hrvoje Jakić, OB Našice, dr. Janko Szavitz-Nossan, SB Magdalena, dr. Aleksandar Trbović, SB Magdalena, dr. Tomislav Šipić, SB Magdalena, dr. Ivana Šmit, Sisak. Prihvaćeno je njihovo članstvo, te će se e-mailom obavijestiti kolege da počnu uplaćivati članarinu, što će i značiti aktivaciju članstva.

Naglašeno je još jednom da će se, nakon što zaživi uplaćivanje članarine putem administrativne zabrane (automatska uplata skidanjem sa svake plaće), provjeriti tko nije sproveo ovu odluku i tim članovima ČE SE UKINUTI ČLANSTVO. Dr Margetić je predložio da se konačni obračun učini do kongresa u Opatiji.

Također je raspravljano o statusu naših članova koji su strani državljanima te je odobreno da budu pridruženi članovi, a ako žele koristiti beneficije članstva u HKD (Kardio list, skupovi), trebaju plaćati članarinu.

Predstavljeni su i dopisi trojice kolegica i kolega koji su zamolili da im se prizna minuli staž iz kardiologije koji su proveli na odjelima i odobri polaganje ispita iz subspecializacije. To su: dr. Nada Smokvina-Čuruvija iz Rijeke, dr. Željka Diklić iz Rijeke te dr. Josip Đurjanček iz Osijeka. Nakon rasprave o životopisima kolega donešena je odluka da im se odobri polaganje ispita bez provođenja staža iz kardiologije prema Pravilniku o užoj specializaciji te je nakon toga jednoglasno zaključeno DA SE ZAKLJUČUJE ODOBRAVANJE POLAGANJA ISPITA I DA SE NAKON OVOG SASTANKA UPRAVNOG ODBORA VIŠE NEĆE UOPĆE RAZMATRATI TAKVE ZAMOLBE.

Također je raspravljano o inicijativi više članova, a ponajprije dr. Samardžića o uvođenju inačice "Fellow" člana u naše kardiološko društvo. Odluka je odgođena dok se ne

29<sup>th</sup> May: Prof. Miličić an invited guest lecturer at the Congress of Cardiology of the Society of Cardiologists of Bosnia and Herzegovina

21<sup>st</sup> -24<sup>th</sup> October: The 8th Congress of the Croatian Society of Cardiology in Opatija. Prof. Miličić again warned that the deadline for reception of abstracts is on the 1<sup>st</sup> of July 2010.

Ad 6. The Society Secretary (Dr. Počanić) made the attendees familiar with the activities on further update of the list of CCS members and the procedure of collection of membership fees. Dr. Margetić, the treasurer, presented a list from some institutions that informed us about the deduction of membership fee amount from the salary. According to this list, Clinical Hospital Dubrava — 13 members; Thalassotherapia Opatija — 22 members, Institute "Srčana" — 20 members, Clinical Hospital Merkur — 8 members, Clinical Hospital Sestre Milosrdnice — 18 members, Polyclinic "Sunce" — 6 members, County Hospital Čakovec — 2 members, General Hospital Varaždin — 1 member, General Hospital Pula — 6 members, General Hospital Slavonski Brod — 4 members. These are only the institutions that sent us a notice, some of them failed to do so, but for the purpose of records, we need to receive a feedback from the accounting departments of the institutions. It was once again emphasized that our prominent members in the medical institutions all round the country must put efforts to remind the colleagues of the obligation of payment of the membership fee and update of the list of the members.

The Secretary showed the recently received applications for the membership in the CCS: Dr. Iva Henezi, Srčana Zagreb, Dr. Arben Ameti, Srčana, Zagreb, Dr. Hrvoje Jakić, General Hospital Našice, Dr. Janko Szavitz-Nossan, SB Magdalena, Dr. Aleksandar Trbović, SB Magdalena, Dr. Tomislav Šipić, SB Magdalena, Dr. Ivana Šmit, Sisak. Their membership has been accepted and the colleagues will be emailed to start paying the membership fees which means their activation of the membership.

It was once again emphasized that after the payment of membership fee starts to be used by means of administrative ban (automatic payment by debiting a sum from every salary), it will be checked who failed to implement this decision and these members WILL BE DEPRIVED OF MEMBERSHIP. Dr Margetić suggested that the final calculation should be finished prior to holding the congress in Opatija.

The status of our members who are foreign citizens was discussed and they were allowed to be joined members, but if they want to be entitled to benefits of membership in the CCS (Kardio list, meetings) they should pay the membership fee.

The letters by three colleagues were presented who asked for the recognition of their previous employment record in the departments and to be approved to take an exam in sub-specialization. These are the following persons: Dr. Nada Smokvina-Čuruvija from Rijeka, Dr. Željka Diklić from Rijeka and Dr. Josip Đurjanček from Osijek. After the colleagues' curriculum vitae were discussed, the decision was made to approve them to take an exam without having employment record in cardiology according to the Regulation of Narrow Specialization and following that it was unanimously concluded THAT THE CONCLUSION



iskristaliziraju točni uvjeti, beneficije i nazivlje takvih članova.

Dr. Đurašević iz KB Dubrava uputio je dopis UO kojim nas upoznaje s inicijativom koja je potekla prije tri godine iz njegove ustanove, da se ustanovi kategorija specijalist uže specijalnosti pri Ministarstvu zdravstva i socijalne skrbi kako bi naša pozicija (posebice kolega koji rade u bolnicama) bila valorizirana kako stručno, dignitetno tako i materijalno. Prof. Miličić je istaknuo da nigdje u svijetu ne postoji praksa da polaganje subspecialističkog ispita doktoru ništa ne mijenja u statusu! Upoznati smo i s birokratskim nezainteresiranim odgovorom naše Komore koja se nije potrudila promaći ovu hvale vrijednu inicijativu. Odlučeno je jednoglasno da se dopisom i HKD javi nadležnim institucijama podržavajući ovu akciju (Ministarstvu zdravstva, Hrvatskom liječničkom zboru i Hrvatskoj liječničkoj komori).

**Ad 7.** Prof. Bergovec je nazočne upozorio na netransparentnost podataka iz registara (onih koje vodimo i koristimo), jer se podaci sliježu u jedno mjesto, ali je dostup do njih drugim sudionicima koji daju svoje podatke ograničen. Također se povela rasprava o Hrvatskom registru akutnog infarkta miokarda koji godinama vodi Poliklinika "Srčana". Nakon kraće rasprave odlučeno je da se pozove na idući sastanak UO prim. mr. sc. Mirjana Jembrek Gostović, prim. dr. sc. Inge Heim te prof. dr. sc. Vjeran Nikolić-Heitzler kako bi se pokušalo poboljšati funkcioniranje postojećih registara. Naglašena je urgentna potreba da se zažive i drugi registri.

Sljedeći sastanak UO zakazan je za 17. svibnja 2010. godine u 17 sati na Medicinskom fakultetu u Zagrebu.

Sastanak je završen u 19,25 sati.

WAS REACHED TO APPROVE TAKING THE EXAM AND THAT FOLLOWING THIS MEETING OF THE MANAGEMENT BOARD SUCH APPLICATIONS WILL NOT BE CONSIDERED ANY MORE.

The several members' initiative was discussed as well, mainly the Dr. Samardžić's initiative of introducing the term "Fellow" member in our society of cardiology. The decision was postponed by the time exact conditions, benefits and such members' names have been clarified.

Dr Đurašević from the Clinical Hospital Dubrava sent us a MB's letter making us familiar with the initiative given some three years ago from his institution, as to establish the category a specialist of narrow specialization in the Ministry of Health and Social Welfare as to evaluate our position (especially the position of the colleagues who work in the hospitals) not only in terms of profession, but also dignity and financially. Prof. Miličić said that nowhere in the world taking a subspecialization exam changes nothing for a doctor in his/her status! We are familiar with administrative answer of our Chamber showing no interest, that made no effort to promote such praise worth initiative. It was unanimously decided that CCS should send a letter to competent institutions supporting this action (to the Ministry of Health, Croatian Doctors' Association and Croatian Chamber of Doctors).

**Ad 7.** Prof. Bergovec warned the attendees of non-transparency of data from the register (those that we maintain and use), since such data is filed in one place, but its access to the other participants that provide their data is limited. The Croatian register of acute myocardial infarction that has been maintained by the Institute "Srčana" for years was discussed. Following a short discussion, it was decided to call Head Doctor Mirjana Jembrek Gostović, M.Sc., Head Doctor Inge Heim, PhD and Prof. Vjeran Nikolić-Heitzler, PhD to the next MB meeting as to try to improve the functioning of the existing registers. An urgent requirement for the activation of some other registers was emphasized.

The next MB meeting was convened on 17<sup>th</sup> May 2010 at 17 o'clock at the Faculty of medicine in Zagreb.

The meeting ended at 19.25 o'clock.
